Syllabus: <p>This curricular component promotes reflection on the interactions between markets and political systems, mediated by national and transnational legal regimes. Throughout the course, the relationships between the economy and politics are explored, highlighting how legal and regulatory systems influence and are influenced by economic activities and political decisions. The course reveals how the debate on the exercise of citizenship impacts the control of economic power, emphasizing the importance of citizen participation in the formation of public policies and economic regulation. To this end, the course debates how economic and social rights are realized through different international political processes, considering the challenges and tensions that arise at the intersection of economic interests and democratic principles. This component promotes the integration and internationalization of the two research lines of the Postgraduate Program in Political and Economic Law, allowing foreign visiting professors and researchers to discuss their academic productions, as well as encouraging reflection on the intersections of the two research lines through collaboration among the Program's faculty.</p>
